## **Greenway Preservation Trust**

Protecting The River/Preserving Our Heritage By Jeff Shoemaker, Executive Director

In November of 1998, the Greenway Foundation announced the initiation of a campaign to provide the beginnings of a permanent endowment for the ongoing protection and preservation of Denver's Great Natural Resource, the South Platte River. Over the course of the last several years, close to \$3 Million has been donated and pledged to this effort. A complete listing of the many individuals and organizations that have made this remarkable achievement possible is contained within this newsletter.

Entitled the Greenway Preservation Trust (GPT), this important source of funds will provide the means of ongoing support for what have been labeled "The Four E's":

#### Education

Each year, the Foundation's Youth Education program, known as S.P.R.E.E. (South Platte River Environmental Education), introduces thousands of young people to the South Platte and helps them realize the significance of the River to the creation and growth of Denver.

#### **Employment**

Over the course of each summer, Punt the Creek provides employment for between 20-25 high school and college aged youth, who serve as guides for the thousands of passengers who enjoy a floating history tour of Lower Downtown Denver along Cherry Creek on one of six punts (similar to gondolas). Each guide provides an entertaining and historical overview of the area known as the birthplace of Denver as well the area known as the birthplace of Denver as well as how this unique summertime amenity was

#### Events

As part of our mission to bring cultural and community involved events to the River, the Foundation hosts the Confluence Concerts series each Thursday evening in July featuring some of Denver's best known entertainers and ensembles. In addition, the last Saturday in September witnesses the return of NIMBY (Not In My Back Yard) Fest, a multi-jurisdictional volunteer based cleanup of the 25 miles of the Riverfront from C-470 to I-76. #### Enhancements

The Foundation continues to partner with various public agencies to provide ongoing environmental and recreational enhancements to the River and its surrounding area. 

#### 2001 Friend Of The River Award Dinner

Each November, the Foundation hosts the annual "Friend of the River" Award Dinner as a fundraiser for the GPT and a means of recognizing individuals who have made a longstanding and significant contribution to the revitalization of the South Platte River Greenway. 2001 witnessed the 3rd year the event has been held, and recognized **Ken and Ruth Wright** for their many years of advocacy and support for the South Platte River Greenway through Denver.



Ken Wright- A civil engineer for close to fifty years, Ken has been involved in the rebirth of the South Platte River both professionally and personally since the efforts of the Greenway Foundation began over 28 years ago. He was responsible for the 1975 design and construction of Confluence Park and the 1982 master plan for the 40 miles of the River through Denver's Metropolitan area for the Urban Drainage and Flood Control District. Since then, Ken and his firm, Wright Water Engineers, have been involved in numerous additional projects along the South Platte as well as Bear Creek, Cherry Creek, Clear Creek and many more. Ken is a veteran kayak and white-water raft enthusiast and, over the last seven years, has performed scientific hydrology research at Machu Picchu and Mesa Verde National Park. He recently authored and published *Machu Picchu: A Civil Engineering Marvel*.



Ruth Wright- Ruth has led numerous successful efforts to improve conditions of the South Platte River during her service on the Colorado Water Quality Control Commission as well as during her 14 years in the Colorado State Legislature, serving 6 years as House Minority Leader. She was a member of the Great Outdoors Colorado (GOCO) Board of Trustees from 1993-99, and served as Chair the last two years. Ruth was instrumental in launching the GOCO legacy grant program that was critical in helping fund improvements along the South Platte. She received her Ph.D from Marquette University and her J.D. from the University of Colorado. Ruth's interests include scuba diving, photography, archaeology and travel. These talents have been applied through her creation of Machu Picchu calendars and *The Machu Picchu Guidebook*, published in 2001.

Thanks to the support and generosity of over 250 guests and donors, and in particular to our returning corporate sponsor, **Camp, Dresser, and McKee**, this year's Award Dinner raised over \$40,000 for the GPT, all of which will help support the programs listed within this article.

The South Platte River is truly Denver's legacy. The River and its banks served as the host for our city's first permanent settlements. Once a source of pride, the River became a wasteland of refuse and pollution, until the determined efforts of the Greenway Foundation initiated the rebirth of Denver's "Only River in Town". By investing in the Greenway Preservation Trust, our Greatest Natural Resource will continue to receive the preservation and protection it deserves.

## **Punt The Creek**

ow! Has it already been 6 years?! It seems like yesterday we were opening Punt the Creek on a cold and rainy day in 1996. We have come so far since then. And what a joy it has been for me to see the changes in PTC, downtown and myself.

I come to Punt the Creek (PTC) with a unique view. Because I have been with PTC from year one, I can appreciate the "blood, sweat and tears" we have gone through to make PTC what it is today. From the early years of flooding, wooden docks, sandbars and washed out landscaping, we have learned that the Creek is a way of life. Like a spouse, you cannot change it, but you grow to know and understand its moods from day to day. We have learned to take in stride the daily challenges as part of the project we call PTC. These challenges make PTC what it is — a dynamic project that many thought could not happen. I applaud those who have stood by PTC and who believed in an "impossibility" that has changed the way many think of Lower Downtown Denver.

Originally, I was hired to make sense of the customer service side of PTC. My job was to run the ticket kiosk. This job entailed much more than I thought it would initially. From keeping the books, maintaining a reservation log and dealing with the public, I was on the "front lines" – the first contact many people had to the unknown entity called "Punt the Creek". The early days posed many challenges for me mentally and physically. Since this was the first time a boating concession was created to operate within an active flood channel, I could only guess how to prepare for the job. As time went on, I found most of our preparations were moot. Daily operations were slow at first, which gave me the opportunity to figure things out as I went along. The fun part was to come later.

As the summers passed by, the question of what PTC was began to diminish. Much to my excitement, most people knew it had to do with a boat instead of a football. We started to train others to run the kiosk so I could do what I most desired: give tours. Customer service was and is our number one priority at PTC. I found quickly that this was a different reality when I was in the kiosk versus when giving tours on the Creek. In the kiosk, I

dealt with people who had all different views of PTC – skepticism to curiosity. As a punt guide, I found people very interested in the adventure and uniqueness of the concession. This was such a delight to me. Finally, I was allowed to connect with people through the joys of history. I truly enjoy being a storyteller, and trust me, PTC is a story that started many years ago and will forever be a part of Denver's rich history.

I am fortunate to be a part of such a unique and dynamic project. Today, PTC is serving our community by providing flavor to our downtown culture. It is now a shining light to all, proving that the "impossible" can be done.

I look forward to many great years of Punt the Creek.

S.P.R.E.E. School Program Blossoms By Carl Crookham, S.P.R.E.E. Program Coordinator

B eginning with the 2001-02 school year, McKinley-Thatcher Elementary School became the first full-fledged S.P.R.E.E. (South Platte River Environmental Education) School. This significant step in the growth of the Greenway Foundation's Youth Education program has three overall goals:

•Bring students to the South Platte River on various field trips designed to teach them about the significance of the River to Denver's past and future, while simultaneousy connecting these experiences to various curriculum disciplines.

•Incorporate the River into these disciplines during regular classroom lessons (i.e. – apples and oranges in a math problem might become bass and trout)

•Encourage a bonding between the students and the South Platte that will help insure its proper care and enthusiastic use in future years.

Over the last three years, the S.P.R.E.E. School concept has been created with the cooperation of McKinley-Thatcher as our pilot program. The following letters from the program's supervising teacher and four of her students (written to Executive Director Jeff Shoemaker) will give you a better understanding of why this expansion of our Youth Education program has been so successful.

#### Dear Mr. Shoemaker:





he Foundation launched its 4th consecutive year of Confluence Concerts, a hallmark summer concert series down on the River. The venue, the site of the Foundation's first project – Confluence Park – yielded spectacular evening views of both downtown and the Rockies on the Western skyline.

Confluence Concerts continue to showcase local artists in an intimate outdoor setting, and last year's featured performers were no exception. The performers included Jarkarta, Liquid Rythumz and the Kool Kats. Attendees were treated to a great evening of entertainment on four consecutive Thursday nights. Infinity Broadcasting, with radio stations KOOL105, MIX100 and Jammin 92.5 returned as radio sponsors along with corporate sponsors Anheuser Busch, Heritage Bank and Kentwood City Properties. Many thanks to these local business sponsors who, along with the Mayor's South Platte River Commission, help support these free community concerts.

The Foundation played host again for the Greenway Relay, a FUNd-raiser for the Greenway Preservation Trust. Teams of four competed in the August heat for the best time in a series of non-stop events: raft, rollerblade, run and... in keeping with the fun-for-all mood of the event, a scooter! In a test of physical stamina, patience and good humor, team members took in succession, the waves of the boat chutes at Confluence Park, the Greenway trail and the paths at Commons Park. The anchor leg was a furious and often wobbly 'scoot' to the finish aboard an Archie-sized scooter. Our thanks goes out to 1st Bank of Cherry Creek- University Branch and the Mayor's South Platte River Commision for sponsoring this event. We also offer our appreciation to Greg Pratt of River Reach Youth Initiative for supplying the rafts, and our volunteers who helped time and monitor the event. Each team member received a medal with the trophy going to Wright Water

Engineers. The event ended on a high note with a lunch for contestants and a bluegrass concert at Confluence Park.

Where would you find countless cans, bottles, fast food wrappers and other assorted trash? If you're thinking, "Not In My BackYard!" you're right! For the 9th year, members of several organizations cooperated in a clean-up in and around the South Platte River for NIMBYFest, sponsored by 1st Bank of Cherry Creek- University Hills Branch, Denver Water, and CH2M Hill. The parks departments of Denver, Adams, South Suburban, Englewood, Brighton and Commerce City participated with volunteers from the Rocky Mountain Canoe Club, Denver Water, UDFCD, COJ, Metro Wastewater and others in a 25-mile long effort to beautify the River. Part of American Rivers' National Rivers Cleanup Week, the Greenway Foundation is Denver's host to this great stewardship event. This year, kids from area schools along with members of the local Boy and Girl Scouts were in the vanguard of volunteers along the River from C-470 to Metro Wastewater above I-70. An estimated 10 tons of waste was hauled away courtesy of Urban Drainage & Flood Control District and BFI. The winner to the "Weird Waste Trophy" this year was South Suburban for a piece of something so unusual, well, you just had to be there. Special thanks to our food sponsors Pudge Brothers Pizza, Zangs and the Spaghetti Factory in Lodo.

Note - Doug Ellis moved back to his native Virginia at the end of last year, where he is currently the associate director of BikeWalk Virginia, a nonprofit organization devoted to creating bike-ped friendly trails and communities. Doug served the Foundation for over four years and played a key role in the creation of our Summer Special Events, the Annual Friend of the River Award Dinner and the initiation of the Greenway Preservation Trust. #### Confluence Concerts

## Three Years and the Count Down!!!!

Mayor's South Platte River Initiative

The section of the River from Lakewood Gulch downstream to I-25 has been completely re-worked to improve flood control and low flow channel capacities. Numerous riparian enhancements have also been added to either bank of theSouth Platte as part of this cooperative effort between the C&C of Denver, Urban Drainage and Flood Control District, the U.S. Army Corps of Engineers and the Greenway Foundation.

When I started this job in April of 1999, the River corridor between Denver's boundaries reminded me of a huge smile, but alas, with a couple teeth missing! Over these past three years, those "teeth" have begun to be filled in and what a beautiful smile is now beginning to emerge along the South Platte River!

From Northside Park to Grant Frontier Park, the restored native vegetation has thrived and multiple missing elements have been completed. The Overland Trail Corridor (Evans to Florida) is now complete and planted and is a huge improvement to the area. The wildflowers last spring were some of the most beautiful in the region and a delight to many. With a new 10' wide multi-use concrete trail and several soft surface trails leading down to seating areas along the banks of the South Platte, this stretch of the River is now accessible to all.

The Colfax Reach Project (from the Bronco Bridge to Lakewood Gulch) is complete. This was a joint project between the U.S. Army Corps of Engineers, Urban Drainage and Flood Control, the City & County of Denver and the Greenway Foundation. The bank restoration and River re-channelization are complete. The wetlands will be planted this fall after this "new" section of the River experiences its first spring run off. If you haven't had a chance to visit this area, you are really missing something!

The Denver County Reach Project (from Lakewood Gulch to 8th Ave) is well underway. Also a joint project with the US Corps of Army Engineers, the feasibility study has been completed and is in Washington, D.C. for final approval. Funding for the Plans and Specifications phase of the project is in President Bush's budget request, and we have had great support from Colorado's Congressional

delegation to help get the necessary funds to improve this section of the River. This project will remove the Xcel Energy fabridam at 13th Ave, but still allow them to obtain the needed water via infiltration galleries to run the power plant. Meanwhile, while we patiently wait for the Federal process of approvals, we are moving forward with the right-of-way acquisition necessary for this remarkable River restoration project.

Centennial Flower Gardens (Little Raven and Speer Blvd) is under construction. Foundations are in place for the entry pavilion and the six fountains. Plants have been chosen and procured and a late August/early September 2002 opening is planned. This garden is being developed through a cooperative agreement with the Department of Parks and Recreation and the Denver Botanic Gardens. It will be open daily, free of charge, and will offer a panorama of native plants, grasses, and water features.

Shoemaker Plaza at Confluence Park (15th and the South Platte River) has begun a total renovation. Although it was determined that, due to the Farmers and Gardens ditch, the pathways leading down to the plaza could not be realigned, the entire plaza itself is being rebuilt, with new lights, planters and raft and kayak access. The top of the Plaza in front of the Riverpoint Building and REI will also see a major facelift! The trolley tracks have been removed and a new pedestrian promenade will be built. For those of you Trolley lovers out there, don't worry, the trolley is still available! Its start/end will now be in front of REI.

An entire new signage program is being put in place along the South Platte River Greenway in Denver, featuring mileage locaters, historic and current points of interest, and other items that add to the enjoyment of experiencing this world class amenity.

The Platte Substation at the Confluence (directly across from Shoemaker Plaza) has long been felt to be a detriment to the birthplace of Denver. The files discussing the move of the power station away from the River go back over 20 years! The real issue has always been-"where to move it"? With a great deal of tenacity from Pete West of Xcel Energy and this office, the unbelievable has finally happened. On November 28, 2001, the City and Xcel Energy entered into an agreement to move the existing station away from the Confluence. Xcel will build a new substation (Lacombe) on land the City helped them acquire from Trillium Corp. and RTD. The old substation site will be developed into the final phase of Commons Open Space. Through a Cooperative Agreement between the Department of Parks and Recreation and the Greenway Foundation, a new park will be developed on a site that many thought would never be anything but a power substation. Look for a master plan of the area to be completed by late summer with construction of the new park to possibly begin as early as January 2003.

The 19th Street Pathway is complete and operational and connects Commons to Cuernavaca Park without the fear of the tight turn space under 19th street resulting with someone ending up "head over heels" into the River.

Phase Two of the Denver Skateboard Park is scheduled to begin construction in January of 2003, after an existing building is demolished in late summer of this year.

The Transfer Station which provides power for the new Lacombe substation is under construction under the 20th street viaduct next to Cuernavaca Park. This will allow Xcel to get power from the West Bank, under the River to the new substation site.

Northside Park Phase Three (Franklin and 52nd) is once again moving forward. This project is the final phase of Northside Park, and will take approximately 100 homes and businesses out of the flood plain. A model of the improvements is being constructed at CSU, to ensure that existing water users will still have access to water, and that the project meets all its intended goals.

Historical and Directional Signage is now installed at the majority of the parks along Denver's 10.5 mile run. The historical signs depict the historic significance of the particular locale while the directional signs tell trail users where they are along the Greenway and how far it is to the next point of interest, or rest! These signage programs have been an onerous task to get completed due to the multiple users, funders and interest groups involved, but truly add another human element to our all-important natural asset, the South Platte River. If you are out and about on the Greenway trail, take a minute to read the signs. I'm sure you'll be surprised about the facts they will bestow!

As you can tell, a lot has been happening, and while there is still plenty to do, we will soon be able to have the River produce a perfect, "tooth filled" grin!

The Greenway Foundation continues to enjoy partnering with numerous public and private organizations to collectively bring about new and expanded amenities to the South Platte River and its various tributaries.

## **Overland Corridor**

Riparian and Recreational Corridor Improvements Nearing Completion By Shaun Gordon, MDG, Inc.

Volunteers like these helped plant several dozen trees and shrubs along the Overland Corridor project this past fall.

Construction of the Overland Corridor improvements between Florida and Evans came closer to completion last fall with a coordinated volunteer planting day. Nearly half of the 170 trees planted along the Corridor were installed with the collaborative effort of the Denver Parks and Recreation "Hands On Denver" program, the South Platte River Restoration Program, Denver Water and the Greenway Foundation.

Within a few weeks following the volunteer day, the remaining landscaping efforts were completed along with an irrigation system to help insure the successful growth of the numerous trees and shrubs that have been added to this seven block section of the South Platte River Greenway.

The first year of the three-year wildflower and native grass seeding program is now underway. This program, in coordination with the City and County of Denver Parks and Recreation Department, expects to be utilized as a template for future seeding projects along the corridor and is a part of the re-establishment of native vegetation along the entire South Platte River corridor in Denver.

A 10' wide concrete trail along the entire corridor, along with several seating areas and soft surface pedestrian trails are also part of the project

The Greenway Foundation is pleased to be a partner with Denver's Parks and Recreation Dept., Great Outdoors Colorado, Denver Water, and the Overland Neighborhood Association in making this special section of the River a better setting for urban wildlife, riparian and recreational uses.

# **Cherry Creek Regional Trail**



When completed, the Cherry Creek Regional Greenway will include over 26 miles of hard surface and equestrian trails, as well as numerous riparian areas.

The final 1.5 miles of the Cherry Creek Regional Trail within Arapahoe County is expected to be under construction this coming summer. This will bring the Regional Trail that connects the Cherry Creek State Park and Castlewood Canyon State Park to within a few miles of completion.

Year Two of the three-year wildflower and native grass seeding program for the first phase of this project, completed in 2001, will get underway this spring. Upon completion of the final phase of trail, the same three-year seeding program will be instigated.

The current residential development in the area will have front row seats to one of the best recreational amenities in the region, enjoying numerous riparian and recreational amenities along the 26 mile corridor of the Creek between Castlewood Canyon and Cherry Creek State Parks since 1986.

The Greenway Foundation continues to enjoy a successful partnership with Arapahoe County in this latest addition to this nationally recognized amenity.



The improvements to the Confluence Park Plaza area will be completed in time for summer of 2002.

The Greenway Foundation and the City and County of Denver have partnered once again to oversee a number of needed repairs and enhancements to Shoemaker Plaza at Confluence Park including replacing missing and broken pavers, adding upgraded planting areas and a re-configured lighting system.

In addition to the plaza renovations, a pedestrian promenade is planned for the area above the channel wall where the trolley tracks are located. Porous concrete pavers will be used to filter stormwater runoff and create an interesting paving pattern that recalls the railroad use of this corridor. With the new REI flagship store adjacent to this project, the area should have intensive pedestrian activity.

Construction started in March 2002 and should be completed by the time this newsletter is published. These needed improvements will help make the birthplace of Denver an even greater amenity.
